### **Important events to be reported:** Closed trading period

The management of Holde Agri Invest S.A. (hereinafter referred to as the "Company") informs the market that on 25.02.2022, at 08:00, the Company will publish the Preliminary 2021 Financial Results and that on 26.01.2022, the Company will enter the closed trading period. This means that the persons discharging managerial responsibilities within the Company within the meaning of Regulation (EU) no. 523/2016 and Regulation (EU) No. 596/2014, shall not conduct any transactions on their own account or for the account of a third party, directly or indirectly, relating to the shares of the issuer or other financial instruments linked to them, during a closed period of 30 days before the publishing of a financial report.

According to internal regulations of the Company, the trading restrictions are also applicable to individuals who have access to privileged information within the meaning of FSA Regulation no. 5/2018 and Law no. 24/2017.

Therefore, since the opening of the trading session from 26.01.2022, the trading activity on HAI shares is not allowed for the persons mentioned herein above. These persons will be able to resume trading on 25.02.2022, after the Company will publish the Preliminary 2021 Financial Results on 25.02.2022, at 08:00, before the market opens.
