Therefore, since the closing of the trading session from 21.10.2022, the trading activity on HAI shares is not allowed for the persons mentioned herein above. These persons will be able to resume trading on 22.11.2022, after the Company will publish the Q3 2022 Financial Results on 22.11.2022, at 08:00, before the market opens.
